Note:-

- (i) Candidate selected for appointment will have to pass requisite Medical fitness conducted by Railway Administration for the post which they are being recruited.
- (ii) Empanelled candidates will be under probation for a period of two years. Before completion of the probation period, the sportsperson shall be reviewed at the Railway/Unit level by a three members committee as mentioned in Railway Board's letter No-2010/E(sports) /4(1)/1(Policy) dated 31.12.2010.
- (iii) If the performance of empanelled candidates is found unsatisfactory, the probation period will be extended maximum up to two years. Even after extended probation, if the performance is found unsatisfactory, then normal procedure will be followed for termination, before the completion of extended probation.
- (iv) Empanelled candidates are required to furnish a service Bond to serve Railway for Five years as per annexure IV of Railway Board's letter No-2010/E(sports) /4(1)/1(Policy) dated 31.12.2010.

- (v) If the empanelled candidates are posted as Jr. Clerk cum Typist they will have to pass the requisite type –writing test within a period of four years from the date of their appointment otherwise regular increment due on completion of four years and thereafter, should not be released. Till such time they passes the type writing test their appointment will be treated as provisional and no promotion/increment will be granted.
- (vi) The appointment of the empanelled candidates will be subject to verification of Educational/Sports certificates from the issuing authority and recognition of issuing authority for recruitment in Railways.
- (vii) The above provisional panel is approved by General Manager on 28.03.2020 and is valid for one year from the date of its approval.
